Palmiro Togliatti Sep 03 2022 Palmiro Togliatti could not have become leader of the Italian Communist Party at a more difficult time in the Party's history. In 1926, while he was away from Italy representing the Party in Moscow, Mussolini's Fascist government outlawed the organisation and arrested all the other leading Communists, including Antonio Gramsci, and Togliatti became leader - but at the cost of living in exile for nearly twenty years. Drawing on unprecedented access to private correspondence and newly available archives, this is the first full biography of this important Communist politician and intellectual. Like many successful politicians, Togliatti was a man of contradictions - the dedicated Party man who was also instrumental in creating the constitution of Republican Italy - whose personal charisma and political acumen kept him at the forefront of Italian politics for nearly forty years. Aldo Agosti explores Togliatti's intellectual development; his achievements and his sometimes criminal mistakes as the leading member of the Comintern; his complex relationship with Moscow; and his lasting impact on Italian politics. The result is a meticulous and fascinating life of one of Western Europe's most successful Communist leaders, which at the same time casts fresh light on the internal politics of the Comintern.

Transitional Justice in Italy and the Crimes of Fascism and Nazism Apr 17 2021 This book presents a comprehensive analysis of the Italian experience of transitional justice examining how the crimes of Fascism and World War II have been dealt with from a comparative perspective. Applying an interdisciplinary and comparative methodology, the book offers a detailed reconstruction of the prosecution of the crimes of Fascism and the Italian Social Republic as well as crimes committed by Nazi soldiers against Italian civilians and those of the Italian army against foreign populations. It also explores the legal qualification and prosecution of the actions of the Resistance. Particular focus is given to the Togliatti Amnesty, the major turning point, through comparisons to the wider European post-WWII transitional scenario and other relevant transitional amnesties, allowing consideration of the intense debate on the legitimacy of amnesties under international law. The book evaluates the Italian experience and provides an ideal framework to assess the complexity of the interdependencies between time, historical memory and the use of criminal law. In a historical moment marked by the resurgence of racism, neo-fascism, falsifications of the past, as well as the desire to amend the faults of the past, the Italian unfinished experience of dealing with the Fascist era can help move the discussion forward. The book will be essential reading for students, researchers and academics in International Criminal Law, Transitional Justice, History, Memory Studies and Political Science.

Democracy, Civic Culture and Small Business in Russia's Regions Dec 14 2020 This book adopts a novel analytical approach to understanding how Russia's stalled democratisation is related to the incomplete liberalisation of the economy. He argues that American intellectuals are as uncritical of Eurocommunism as they were after the first flush of Allied victory in World War II, that the Carter administration's foreign policy was incoherent, and that the United States needs a consistent, ideological approach to communism--one that includes the capacity for action as well as reaction. Michael Ledeen is a senior associate of the Center for Strategic and International Studies at Georgetown University, and formerly taught history at Washington University. He was the founding editor of *The Washington Quarterly*, and is the author of, among other works, *Grave New World*; *The First Duce: D'Annunzio at Fiume*; and editor of *U.S. Defense and Foreign Policy*.
